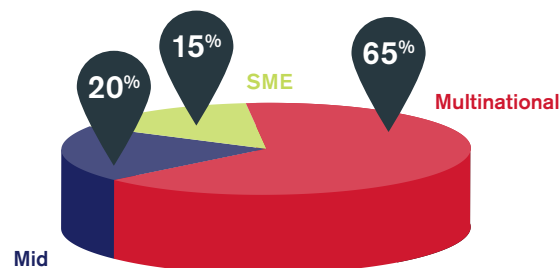

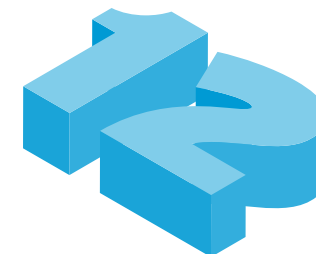

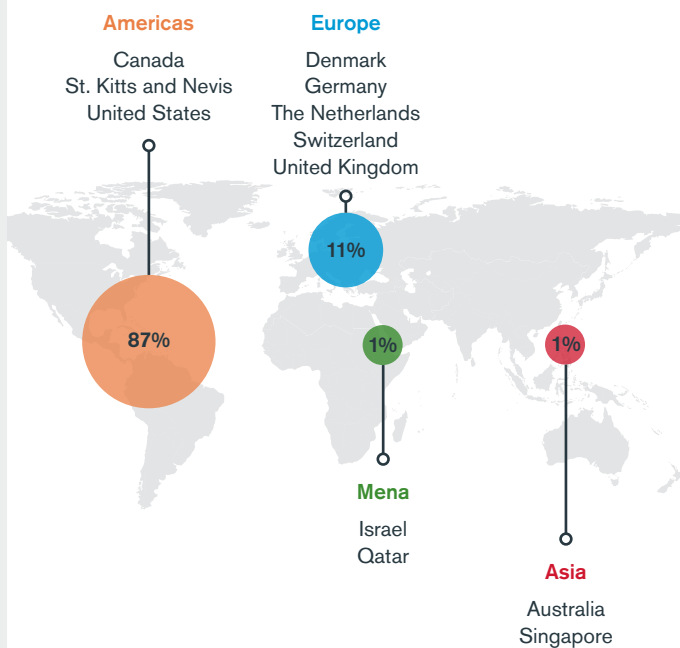
Company size breakdown

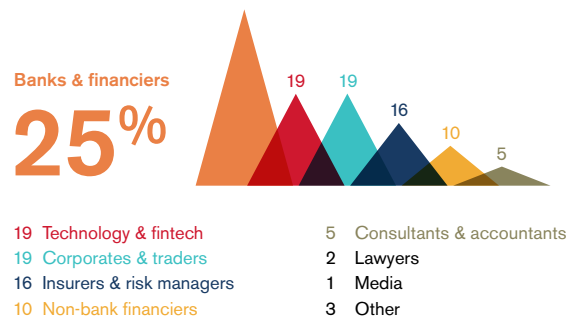

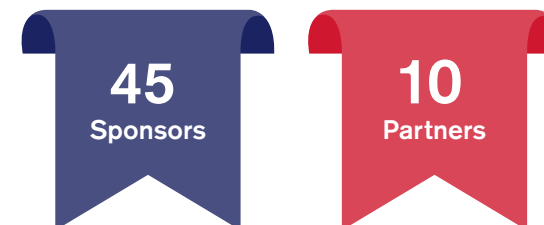
