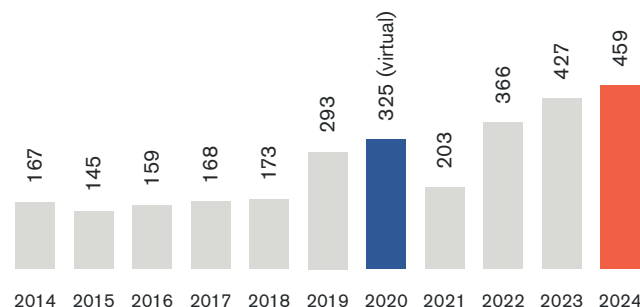

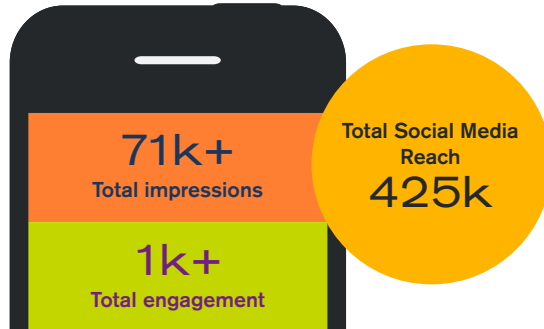

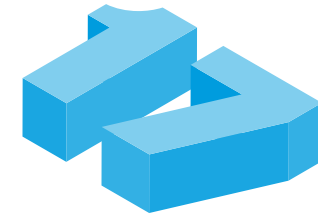
### Social media engagement in 2024



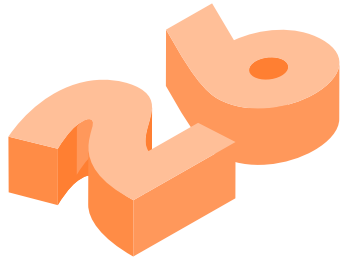
### Attendees by sector in 2024

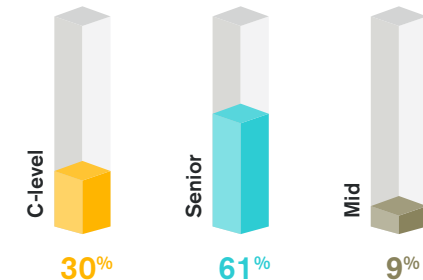
### Countries represented in 2024



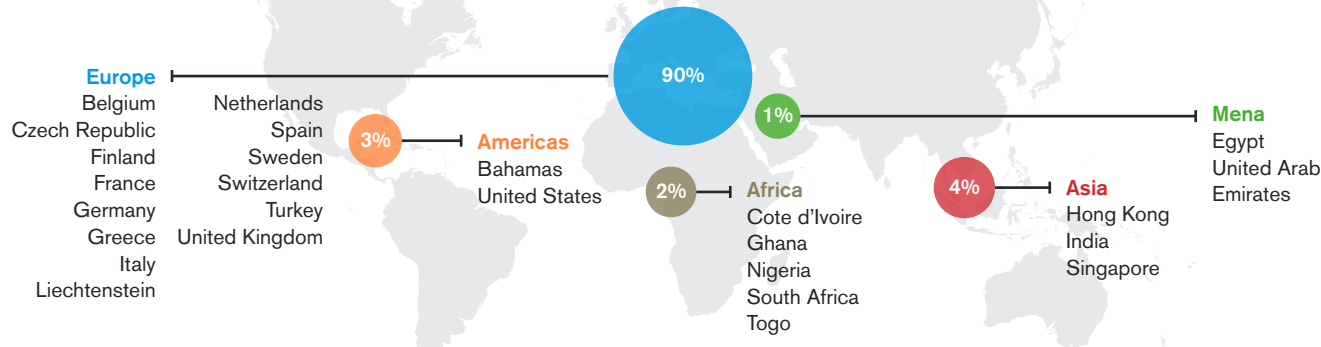
